



TERMS OF COMPETITION

- 1. The tournament is open to amateur men and women aged 20 years and over, with a current World Golf Handicap
- 2. The maximum starting handicap for men is 28 and 36 for women under the PaR nz Points System.
- 3. Your starting handicap is based on your current affiliated handicap index from DotGolf or GA from Australia Golf Link as at Friday 12 August 2022. The slope rating on the Denarau Golf Course, your starting course will be applied as per the USGA Slope System.
- 4. All handicaps will change daily according to the PaR nz Points System.
- 5. The field is limited to the first 200 entries received with a deposit. Payment in full must be made to complete your entry
- 6. Entries shall only be received online www.parnz.co.nz/tournaments.
- 7. The Tournament committee reserves the right to refuse entry to anyone, without having to give a reason.
- 8. The Tournament is a team's competition (2 players) with any combination of men and/or women
- 9. The scoring format is the fun PaR nz Points System. All daily scores contribute to the team score
- 10. Overall team prizes will be awarded at the Friday Awards Dinner & Party Players may win more than one daily prize across the competition rounds.
- 11. In the event that teams are tied, a count-back to determine the daily winners or place-getter will be conducted over the top individual players score to lowest individual players score to decide a winner.
- 12. After 4 rounds, In the event that teams are tied, a count-back to determine the overall winners or place-getter will be conducted over the last round of 18 holes will be counted, and if still tied then Round 3 (18 holes), then Round 2 (18 holes), then Round 1 (18 holes),
- 13. The Tournament will be played under the Rules of Golf, the Terms of Golf and the following issued at the tournament, local rules, health & safety, including any needed Covid 19 protocols.
- 14. Players are expected to conform to all rules and regulations as may be issued.
- 15. The Tournament Committee reserves the right to amend any condition and / or to alter the number of playing days in the case of inclement weather.
- 16. Should any day forced to be abandoned or cancelled the number of tournament rounds contributing to the overall team and individual points will be reduced accordingly.





BOOKING CONDITIONS

The SHERATON FIJI BULA REUNION ('Tournament') is offered and managed by PaR nz Corporate Events Limited ('PaR nz') (T/A PaR nz Golfing Holidays). Preliminary bookings and tee times have been booked at the Sheraton Fiji Resorts, Denarau Golf Course and NatadolaBay Golf Course. However, in the extraordinary event that these need to change, every effort will be made to make suitable alternative arrangements with all players.

Prices are based on tariffs and local Fiji tax rates current as at the 1st April 2022. If we are forced to change your booking or part of it for reasons beyond our control, for instance, if an airline changes its timetable, or the Fiji Government changes their tax system, we will give you notice thereof, including any change in price.

PaR nz reserves the right to change golf courses and hotels to that which is advertised, providing a replacement of similar standard is substituted. In the unlikely event that a day's play is cancelled due to course closure, PaR nz will endeavour to make alternative arrangements where possible.

PaR nz accepts no liability for any act or omission whatsoever, whether negligent or otherwise, for any Airline, Hotel, Operator or Person providing services in connection with this tournament. We do not accept responsibility for any injury, death, damage, loss, delay, change of schedule or any other events which are beyond our control. PaR nz has made every endeavour to ensure that all details are correct at time of printing but cannot accept responsibility for subsequent change or withdrawal of prices, details or services shown.

- PaR nz recommends all travellers refer to their Ministry of Foreign Affairs in their relevant countries
 and destination countries for general travel advice and COVID or other specific advice. You can
 register your travel plans with the Ministry so that you may be more easily contactable in an
 emergency.
- PaR nz strongly recommends that you should familiarise yourself with the current status and updates of your country of travel origin during COVID so that your travel documents comply and you have taken the appropriate insurance for protection.

HEALTH

PUBLICITY

• PaR nz may arrange media promotion and publicity before, during and after the Tournament. Competitors assent to references to them and pictures of them appearing and being used for purposes determined by PaR nz.

- By entering this PaR nz event managed tournament, you agree to be added to the PaR nz database

 materials as may be sent by post, including specific updates as they pertain to the event you have just
 entered.

CANCELLATION

- If you cancel for any reason, prior to 60 days your monies paid will be refunded to you less a cancellation fee of 10%.
- There are no refunds where you cancel within 60 days of the tour start date.
- Or <u>under special consideration</u>, monies paid <u>maybe</u> transferred to another competitor or *PaR nz* tournament or tour by agreement.
- There are no refunds where you cancel after the tour start date.





PAR NZ CANCELLATION - FORCE MAJEURE CLAUSE

In the <u>unlikely</u> event that PaR nz, is forced to postpone or cancel the Tournament because of exceptional circumstances outside of our control, we will offer alternative arrangements:

- Offer a postponed date or postponed arrangements
- Transfer 100% of the funds received to date, to another PaR nz tournament or tour, scheduled within a 12-month period, (or longer as mutually agreed).
- Alternatively, where PaR nz <u>can</u> retrieve funds from suppliers for bookings made on your behalf, PaR nz will refund 90% of all monies paid.
- The three options are all subject to time frames that may or may not be within *PaR nz'* s control but at all times PaR nz, <u>unreservedly</u>, looks to be fair and reasonable with all clients providing funds paid on your behalf can be retrieved from our suppliers.

DISPUTE RESOLUTION

• The laws of New Zealand govern this General Booking Condition document. In the event that there is a dispute regarding a booking, *PaR nz* in the event where the matter cannot be resolved may appoint an independent arbitrator.
