The Golf Tournaments

The Denarau Women's Golf Classic is a women's pairs tournament, open to all ages and with a maximum course handicap limit of 36. The three official rounds of the Denarau Women's Golf Classic will be hosted on the Denarau Golf Course playing Foursomes, 4BBB and Combined Stableford formats. The opening day is a fun teams Ambrose Format. Daily fun prizes are awarded as well for the overall winners. Maximum handicap 36.

The Villa Challenge is a 4-person team competition. You can make your team up with any combination of men and / or women. If you don't have a team, we can find you one. Maximum course starting handicaps apply, 28 for men and 36 for women. The competition is played over four rounds where each player's daily score contributes to the overall team score. Points are scored under the PaR nz Points System™.

We have a great prize table where team winners are awarded trophies and prizes at the farewell dinner.

Terms of Competition

The 2025 Sheraton Fiji Denarau Women's Golf Classic and 2025 Sheraton Fiji Villa Teams Challenge ("the Tournaments") shall be under the management and control of PaR nz Corporate Events Limited t/as PaR nz Golfing Holidays, PaR nz whose decision on all matters relating to the Tournaments shall be final.

General

- 1. The Tournaments will be (four rounds) of golf to be conducted on Monday, Tuesday, Thursday and Friday of each tournament week with Wednesday set aside as a rest day.
- 2. Entries shall only be received on-line https://www.parnz.co.nz/play-abroad with a deposit payment then later invoiced for full payment.
- 3. Entries will be taken up to the Tournament date unless filled prior.
- 4. For each tournament, the field is limited to the first 120 entries received and confirmed on-line with full payment on a 'first come, first served' basis. All golfers entering on-line will receive an electronic confirmation of entry and payment receipt.
- 5. The Tournaments are open to amateur men and women golfers, with a current World Golf Handicap.
- 6. Competitors must have an official New Zealand DOTGOLF Handicap, Australian Golf Link GA Handicap, Fiji Golf Link GA Handicap or an international equivalent.
- 7. The committee accepts that handicaps may alter from the time of entry to the start of the tournament.
- 8. There is fun daily prize giving and overall winners will be announced during the Farewell Prize giving Function
- 9. To comply with Licence Laws, all players must be over 20 years of age, as of the first day of the tournament
- 10. In the event that weather conditions prevent all the players from finishing their round, that Competition round will be cancelled and the tournament reduced accordingly.
- 11. All prizes will be distributed in accordance with the Rules of Amateur Golf Status.
- 12. The Tournament will be conducted in accordance with the Rules of Golf and such Local Rules as approved by the PaR nz.
- 13. All competitors are responsible for all damage to hotel property including any damage in hotel rooms and / or golf carts.
- 14. PaR nz Golfing Holidays reserve the right to change golf courses and venues to that which is advertised providing a replacement of a similar standard is substituted.
- 15. The PaR nz reserves the right to refuse entry to anyone, without having to give a reason.
- 16. The Tournament will be played under the Rules of Golf, the Terms of Golf and the following issued at the tournament, local rules, health & safety, including any needed Covid 19 protocols.
- 17. Players are expected to conform to all rules and regulations as may be issued.
- 18. The PaR nz reserves the right to amend any condition and / or to alter the number of playing days in the case of inclement weather.
- 19. Should any day forced to be abandoned or cancelled the number of tournament rounds contributing to the overall team and individual points will be reduced accordingly.
- 20. PaR nz Golfing Holidays reserve the right to change golf courses and venues to that which is advertised providing a replacement of a similar standard is substituted.

Denarau Women's Golf Classic

- 21. The Tournament will be 54-holes (three rounds) of a 4BBB Stableford, Foursomes Stableford and Combined Stableford competition conducted on Tuesday, Thursday and Friday. The Monday is set aside as a fun Ambrose day.
- 22. The Tournament is a women's pairs competition (2 players)
- 23. The maximum playing handicap for women is 36. The committee accepts that handicaps may alter from the time of entry to the start of the tournament.
- 24. Fun prizes will be awarded daily, in addition to overall winners determined by the highest aggregate of Stableford points over the three competition rounds.
- 25. All handicaps will be frozen for the duration of the Tournament.
- 26. Your playing handicap is based on your current affiliated handicap index from DotGolf or GA from Australia Golf Link as of Saturday 13 September 2025. The slope rating on the Denarau Golf Course, your starting course will be applied as per the USGA Slope System.
- 27. If players are tied, a count-back to determine the winners or placegetter will be conducted as follows. A count back of the last 18 holes will be counted, and if still tied then the last 9 holes, then the last 6 holes, then 3 and then the last hole played. If still tied, the count-back will be decided by lot.

Villa Teams Challenge

- 28. The Villa Teams Challenge is a team's event (4 players) of any male, female combination.
- 29. The maximum course starting handicap for men is 28 and women 36. The committee accepts that handicaps may alter from the time of entry to the start of the tournament.
- 30. Your initial (Round 1) playing handicap is based on your current affiliated handicap index from DotGolf or GA from Australia Golf Link as of Saturday 20 September 2025. The slope rating on the Denarau Golf Course, your starting course will be applied as per the USGA Slope System.
- 31. Golfers score their daily rounds using the PaR nz Points System ™ and where handicaps will change daily.
- 32. For daily team scores, all 4 players scores count.
- 33. Overall team winners are determined by the highest aggregate points over the 4 competition rounds.
- 34. Winners will be announced during the Awards Dinner & Party
- 35. If team scores are tied after 4 rounds, a count-back to determine the winners or placegetter will be conducted as follows. A team score-count back of the last round, round 4, and if still tied then Round 3, then Round 2 and then Round 1. If still tied, the count-back will be decided by lot.

Booking Conditions

The following are general booking conditions for Fiji 2025 tournaments managed by PaR nz Corporate Events (trading as PaR nz Golfing Holidays) *refer to as PaR nz* – namely the Sheraton Fiji Denarau Women's Golf Classic and Villa Teams Challenge.

All terms and conditions including payment schedules are set as per supplier terms which have become more stringent and, with limited, if no, flexibility after COVID.

If for reasons outside of our control, *PaR nz* must cancel either of the 2025 tournaments, an alternative will be offered or postponed arrangements advised. The options are all subject to time frames that may or may not always

be within our control but *however PaR nz*, <u>unreservedly</u>, looks to be fair and reasonable with all clients <u>providing</u> funds paid on your behalf can be retrieved from our suppliers.

The Committee are aware of the rights of consumers and will always comply with all obligations and requirements of the laws of New Zealand as they apply to *The Committee* and are relevant to any booking completed in accordance with these terms and conditions.

Registration with payment of the required deposit or payment in full constitutes your acceptance of all Booking Conditions and / or Terms of Competition for the relevant tournament. The balance of payment for the remaining package is detailed and dated. Failure to make these further payments may result in the cancellation of your place, with NO refund being issued. Visa and Mastercard are accepted credit cards for payment online.

GENERAL

- 1. PaR nz reserve the right to change the programme and function venues based on advice at the time.
- 2. PaR nz reserve the right to change golf courses and venues to that which is advertised providing a replacement of a similar standard is substituted.
- 3. All travelers are responsible for any damage to hotel & golf club property including any damage in hotel rooms and / or golf carts.
- 4. PaR nz accepts no liability, cost or penalty for any loss to any client because of the failure for any reason of any third party to provide services that may be included in terms of any booking made under these conditions.
- 5. For accuracy, Bookings Conditions as stated at the time of booking with your payment are the conditions for which you have agreed, regardless of any general notations recorded on the Bay of Plenty 5 Course Classic website
- 6. *PaR nz* reserves the right to decline registrations for any programme. A decline of registration would be exercised in exceptional circumstances only and after due consideration.
- 7. All events, tours and tournaments hosted by *PaR nz* will be conducted according to the COVID-19 protocols advised by the respective Government, of the countries where the event is being hosted. These protocols are subject to change at any time.
- 8. All golfers play on each course under their own responsibility towards others and all equipment.

TRAVEL RISK & TRAVEL ADVICE & INSURANCE

- 9. All travelers registered with the required deposit or event payment, travel at their own risk.
- 10. PaR nz, sponsors, hotels, host golf clubs and other suppliers of goods or services accept no liability for any death, injury, property loss or damage incurred during or arising out of any aspect of the conduct of the tour or tournament.
- 11. PaR nz strongly recommends comprehensive medical and travel insurance is taken by each person travelling, especially internationally to cover all eventualities, including hospitalization and medical evacuation. Furthermore, we suggest that all travelers check the maximum pay-out restrictions on their policy.
- 12. You acknowledge that you are choosing to travel at a time where you may be exposed to COVID-19 and that your travel plans may be impacted by COVID-19. It is your own responsibility to familiarize yourself with all relevant travel information, including health risks and travel restrictions, (covering border closures, quarantine and isolation requirements).
- 13. You acknowledge that your decision to travel is based on your own consideration of this information and that you agree that you are aware and assume responsibility for all the risks associated with travelling at this time. To the fullest extent permitted by law, we accept no liability in relation to any of these additional risks.

HEALTH

- 14. You must ensure that you are fully aware of any personal health requirements, and recommended precautions relevant to your travel booking, and ensure you carry all necessary vaccination documents.
- 15. Acceptance of these terms confirms that you are in good health and able to travel, including on the proposed dates.
- 16. Acceptance of these terms acknowledges that you have the necessary golf skills / handicaps for playing the included golf, (unless travelling as a non-golfer).

PUBLICITY, PRIVACY AND ELECTRONIC DATABASE MARKETING

- 17. PaR nz acknowledges your privacy is important. We will not share your personal information such as address, email and phone number with other clients or third parties without your consent or knowledge, and / or authorization.
- 18. PaR nz may arrange media promotion and publicity before, during and after a tour or tournament. Competitors assent to references to them and pictures of them appearing and being used for purposes determined by PaR nz.
- 19. By entering this you agree to be added to the tournament and *PaR nz* databases and to receive electronic on-going communications including email newsletters, electronic flyers, and materials as may be sent by post, including specific updates as they pertain to the event you have just entered.

CANCELLATION PROTOCOL - Cancellation by you the Registered Traveller

- 20. First deposits are non-refundable at all times.
- 21. Subsequent deposits and final balance payments are non-refundable at all times.
- 22. Or <u>under special consideration</u>, monies paid <u>maybe</u> transferred to another *PaR nz* tournament or tour by agreement but only where refunds can be secured from suppliers.
- 23. There are no refunds for any services where you cancel after the tour start date.
- 24. PaR nz cannot be held responsible if the golf course cannot be used because of weather conditions or unknown scheduled changes at the golf course. In all situations, faced with possible last-minute situations, PaR nz will attempt to provide a fast and acceptable solution or alternative.

DISCLAIMER

25. *PaR nz* has made every endeavor to ensure that all details are correct at time of printing but cannot accept responsibility for subsequent change or withdrawal of prices, details or services shown.

DISPUTE RESOLUTION

26. The laws of New Zealand govern this General Booking Condition document. If there is a dispute regarding a booking, *PaR nz* in the event where the matter cannot be resolved may appoint an independent arbitrator.
